### **PRIVACY POLICY**

"EDI Messages" means data structured in accordance with an internationally agreed standard and any other standard as Tradelink considers appropriate and transmitted by electronic means through Tradelink Services.
"Government" means the Government of Hong Kong.
"Hong Kong" means the Hong Kong Special Administrative Region of the People's Republic of China.
"Intended Recipient" means any person or party to whom any Messages are intended by the sender to be sent through or incidental to any of the Tradelink Services.
"Messages" means both "EDI Messages" or "Other Messages".
"Messages" means both trough or incidental to any of the Tradelink Services, including data received or transmitted through e-mail, flat file transfer and image file transfer.

### ose of Collection and Use of Personal Data

- In order for you to use Tradelink Services, it is necessary for you to provide us with certain essential personal data as required in the Tradelink Registration Forms and other documents in relation to Tradelink Services, including without limitation, all forms for using Tradelink Government Services. We may also ask you for other information which helps us offer you allored products and services that we think may be of interest to you. The types of personal data we may collect include your name, address, email, telephone number, Hong Kong identity card number, your business information such as company name and business title
- Tradelink shall observe the PDPO and procure all staff of Tradelink to comply with the reasonable standards of confidentiality. Your personal data will be used for the purposes of:

providing Tradelink Services to you; providing you with regular communications from us with details of our business and our products and services; handling of your complaints and inquiries; research and analysis of the data in the aggregate; marketing of services from time to time provided or recommended by Tradelink or Tradelink's subsidiaries, respectively of properties or provided or recommended by Tradelink or Tradelink's subsidiaries, (i) (ii) (iii) (iv) (v)

- You agree that Tradelink may disclose and transfer your Trader Data or personal data to any of the following parties within the same jurisdiction or from one jurisdiction to another in compliance with the requirements of the PDPO: any agent, contractor or third party service provider who provides administrative, telecommunications, computer, payment or securities clearing or other services to Tradelink in connection with any Tradelink Services; it. the Government agency, authority, a third party appointed by Government; any person where such disclosure is required by law; iv. any person owing a duty of confidentiality to Tradelink, including any subsidiaries or associated companies which have undertaken to keep such information confidential and our professional advisors and consultants; or vi. any actual or proposed assignee of Tradelink or transferee of Tradelinks or obligations.
- Save and except for the above purposes and subject to clause (5) above, Tradelink shall not disclose the personal data to any third party (other than the Intended Recipient) without the consent of the Customers.
- Tradelink shall restrict access to personal data to officers, employees, consultants and agents of Tradelink who have a need to know or use the data and who have been trained to handle such data and observe confidentiality properly.
