YOUNG INDUSTRIALIST AWARDS OF HONG KONG 2023

宗旨

「香港青年工業家獎」為香港工業總會（工總）的年度盛事，於1988年首次舉辦，旨在表彰成就超卓、對香港經濟及社會發展有傑出貢獻的年輕工業家，從而啟發更多青年才俊投身工業，實踐和發揚香港工業追求卓越的精神。

參選資格

候選人須符合下列各項資格：

- （一）截至2023年6月2日止，年滿21歲又未足46歲（即1977年6月3日或以後出生）；
- （二）持有香港身份證；
- （三）服務機構為香港註冊的公司，並主要從事工業；
- （四）經個人或機構提名。

評審準則

評審委員會將由工總邀請具威望的社會賢達及資深工業家組成，按候選人的成就、遠見、貢獻及誠信挑選得獎人。

成就： 所屬企業的營運狀況良好，業績優越。

遠見： 具創意及前瞻性思維，準確掌握所屬行業及經濟走勢。

貢獻： 熱心推動行業發展，積極投入社會服務，願意履行企業社會責任，為香港貢獻一己所長。

誠信： 品行端正，誠實可靠，業務操守受同儕認同。

提名程序

截止提名日期：2023年6月2日（星期五）香港時間23時59分

（經網上或電郵方式遞交，時間將以主辦機構伺服器之時間為準；經郵寄方式遞交，日期將以郵戳為準。逾期遞交將不獲受理。）

請填妥提名表格，並由提名人與候選人聯署作實。經填妥的提名表格連同佐證文件及報名費用於提名截止日期前經網上/電郵/郵寄方式呈交工總。

評審委員會成員及主辦機構職員不得提名候選人或被提名參選。

提名人可提名多位候選人。每提名一人，請填寫一份提名表格。

候選人應提交下列資料及佐證文件，以供審查：

1. 候選人的香港身份證影印本；
2. 公司簡介及/或年報及/或認股書；
3. 公司商業登記證副本；
4. 產品目錄（如有）；
5. 公司過去三年經審核及綜合的財務報表（2020、2021及2022財政年度）；
6. 股東名單（如有）；
7. 候選人過去所得獎項或推薦之證明副本；以及
8. 公司架構圖以顯示候選人的職級及職務。

提名人和候選人提交的資料，將會交由甄選委員會和評審委員會作評選之用。因此，所提供的資料越詳盡，對評審工作越有利。

所有提交的資料將嚴加保密，只供甄選委員會和評審委員會作評選之用，並只在候選人當選後摘取適當部分公布。

評選

決選日期：2023年8月中旬

初選

所有提名會經甄選委員會審查後再推薦予評審委員會考慮。

決選

只有甄選委員會推薦之候選人，方能進入決選，主辦機構將以書面通知進入決選之候選人有關決選面試的安排。

入圍決選之候選人必須出席決選面試方能取得獲獎資格。

OBJECTIVES

The "Young Industrialist Awards of Hong Kong" has been an annual flagship event of the Federation of Hong Kong Industries (FHKI) since its inception in 1988. It aims to honour outstanding young industrialists with significant achievements and commendable contributions to the economic and social development of Hong Kong, as role model to inspire the next generation and arouse their dedication to industry and pursuit of excellence.

ELIGIBILITY

To be eligible, a candidate must be:

1. Aged between 21 and 45 on or before 2 June 2023 (i.e. born on or after 3 June 1977);
2. Holder of Hong Kong Identity Card;
3. Working for a Hong Kong-registered company principally engaging in manufacturing; and
4. Nominated by an individual or an organisation.

JUDGING CRITERIA

The FHKI will form a reputable judging panel comprising prominent public figures and leaders of industry to select awardees based on the achievements, vision, contributions and integrity of candidates.

Achievements: Excellent business operations and outstanding achievement.

Vision: Innovative, visionary and with a good grasp of economic and industrial development trends.

Contributions: Committed to industry and advancing its progression, dedicated to community service and corporate social responsibility, and contribute to the betterment of Hong Kong.

Integrity: Honorable and with respectable personal integrity and business ethics.

NOMINATION PROCEDURES

Deadline for Nominations: 2 June 2023 (Friday) HKT 23:59

(For application by online system/ email, the deadline will be based on the server time of the organiser; for application by post, the postmark date will be regarded as the date of application. Late application will not be accepted.)

Each nomination must be submitted in the prescribed form endorsed by both the nominator and the nominee by online system/ email/ post, together with supporting documents and application fee to the FHKI by the nomination deadline.

Members of the judging panel and employees of the organiser are not eligible to nominate or to be nominated.

Nominators may submit as many nominations as they wish. Separate nomination forms should be used for each nominee.

Each nominee should submit the following documents for examination:

1. A copy of the nominee's Hong Kong identity card;
2. Company brochure(s) and/ or annual report(s) and/ or prospectus;
3. Copy of Business Registration Certificate;
4. Product catalogue(s) (if any);
5. Audited and consolidated financial statements for the past three years (fiscal year 2020, 2021 & 2022);
6. List of shareholders (if any);
7. Copies of commendations, statements of authorities, honours and awards which verify to and substantiate the nominee's achievements or contributions; and
8. An organisation chart indicating the position and responsibilities of the nominee.

Information submitted by the nominator and nominee will be taken into account by the screening committee and the judging panel when assessing merits of the nominee. Providing as many details as possible would facilitate the judging process.

All information submitted will be kept strictly confidential except for evaluation by the screening committee and the judging panel. Appropriate information will only be released if an award is granted.

JUDGING

Final Judging: Mid-August 2023

Preliminary Screening

Screening committee members review all nominations and recommend those that should be considered by the judging panel.

Final Judging

Shortlisted candidates who have been recommended by the screening committee will be notified in writing after the preliminary screening and invited to attend the final judging.

The shortlisted candidates must attend the final judging session to be eligible for an award.

宗旨

表揚一位對香港工業和社會作出重大貢獻的工業家。

參選資格

不設年齡限制。被提名人必須是從事工業的香港居民。
評審委員會成員及主辦機構職員不得提名候選人或被提名參選。

評審準則

按提名人的傑出成就及其對香港工業和社會作出的貢獻評選。

提名程序

截止提名日期：2023年6月2日（星期五）香港時間23時59分

（經網上或電郵方式遞交，時間將以主辦機構伺服器之時間為準；而經郵寄方式遞交，日期將以郵戳為準。逾期遞交將不獲受理。）

提名對公眾開放。提名人在遞交提名表格時毋須知會被提名人。

評選

決選日期：2023年8月中旬

初選

所有提名會經甄選委員會審查後再推薦予評審委員會考慮。

決選

評審委員會負責選出一位傑出工業家獎得主。有關評選工作及頒獎典禮將與「香港青年工業家獎」同時進行。

頒獎

頒獎典禮日期：2023年11月上旬

主辦機構將向得獎者索取進一步資料作宣傳之用。得獎者必須親身出席記者會及頒獎典禮以領受獎項。如未能親身出席上述兩個活動，得獎者將被視作自動放棄獲獎資格。得獎者不可授權代領或補領獎項。

提名人亦必須出席頒獎典禮。得獎者及提名人將分別獲頒贈獎座及紀念品。

倘得獎者獲多位提名人提名，紀念品將頒贈給最先遞交提名表格至主辦單位的一位提名人。

（香港青年工業家獎2023候選人適用）

請將報名費用（每位候選人—港幣500元）於截止提名日期前呈交工總。提名一經確定後，所有已繳付之費用不設退款。

OBJECTIVES

To honour an outstanding industrialist who has made significant contributions to Hong Kong industry and community.

ELIGIBILITY

No age limit to the nominees, but the nominee must be Hong Kong residents and actively engaged in industry. Members of the judging panel and employees of the organiser are not eligible to nominate or to be nominated.

JUDGING CRITERIA

A nominee is selected based on his or her contributions to the Hong Kong industry and community, along with a proven record of achievement.

NOMINATION PROCEDURES

Deadline for Nominations: 2 June 2023 (Friday) HKT 23:59

(For application by online system / email, the deadline will be based on the server time of the organiser; for application by post, the postmark date will be regarded as the date of application. Late application will not be accepted.)

All nominations are open to the public. Nominators are not required to inform their nominees upon submission of the nomination forms.

JUDGING

Final Judging: Mid-August 2023

Preliminary Screening

Screening committee members review all nominations and recommend those that should be considered by the judging panel.

Final Judging

The judging panel will be responsible for selecting the award winner. The judging process and award presentation will take place in conjunction with the "Young Industrialist Awards of Hong Kong".

RECOGNITION

Date of Presentation Ceremony: Early November 2023

The organiser will obtain further information from the award winner for publicity purposes. The awardee must attend the Press Conference and the Presentation Ceremony in person in early November 2023 to be eligible to receive the award. The awardee(s) will be disqualified if he/ she is absent from the above-mentioned events. Any authorised third-party is not allowed permitted to receive the award. Requests for receiving the award in occasions events other than the above- those mentioned events above will not be entertained considered.

The awardee's nominator must also attend the award presentation ceremony. Trophies and souvenirs will be presented to the winner and his/ her nominator respectively at the presentation ceremony.

If the awardee has more than one nominator, the souvenir will be presented to the one who first submitted the nomination form to the organiser.

Please settle the application fee (HK\$500 per nominee) on or before the nomination deadline. Application fee is non-refundable upon successful application.
