Hong Kong Summit


Seeing the escalating importance of regional cooperation to the on-going development of economies, the Chamber staged the second Hong Kong Summit with the theme of regional cooperation between Hong Kong and East Asia. Attended by some 800 people, the summit brought together ministerial-level and principal officials, business leaders and scholars from East Asian countries, Mainland China and Hong Kong to explore the latest economic development of East Asia and discuss Hong Kong's roles in promoting economic cooperation in the region.

Visit to Indonesia

The Chamber's Chairmen visited Jakarta, Indonesia and met with officials including Hatta Rajasa, Coordinating Minister for Economic Affairs of Indonesia; Gita Irawan Wirjawan, Minister of Trade of Indonesia; Liu Jianchao, Chinese Embassy in Jakarta; Subash Bose Pillai, Director for the Market Integration Directorate of the ASEAN Secretariat; and Fong Ngai, Director of the Hong Kong Economic & Trade Office (ASEAN). They discussed with the officials the prospects of Indonesia-Hong Kong economic cooperation, as well as the opportunities that can be unfolded by Hong Kong's accession to China-ASEAN Free Trade Area. Calls on East Asia Consulates in Hong Kong

To enhance ties with ASEAN countries, the Chamber called on consulates-general of Cambodia, Indonesia, Korea, Laos, Malaysia, Myanmar, the Philippines, Singapore, Thailand and Vietnam in Hong Kong for sharing ideas on Hong Kong's role in the CAFTA context.

研究香港加入 CAFTA

為深入探討香港加入 CAFTA 對區域經濟產生的作用,特別委託馬來西亞獨立研究機構亞洲策略與領導研究院進行研究。

是次研究採用一般均衡模型分析,推算香港加入 CAFTA 前後對東盟地區經濟環境的影響。亞洲策略與領導研究院首席執行官丹斯里拿督楊元慶博士在發佈會上指出,香港若能加入 CAFTA,有助推動區內服務及貨物貿易增長,進一步促進區域經濟融合發展。(24/8)

Study on Hong Kong's Joining CAFTA

To analyze the implications of Hong Kong's entry to CAFTA on the regional economy, the Chamber commissioned the Asian Strategy & Leadership Institute (ASLI), a leading independent think tank in Malaysia, to conduct a study.

The study employed the General Equilibrium Model (GTAP) to compare ASEAN's economic conditions before and after Hong Kong's accession to CAFTA. On a press conference that unveiled the result of the study, Michael Yeoh, CEO of ASLI, gave a detailed account on the study findings, which showed that Hong Kong's joining CAFTA could stimulate the growth of trade in goods and services and boost the development of service industries in a regional context.
